
2. *The vigilance clearance in respect of the officer marked at SL No. 37 is withheld. The concerned Circle is requested to regulate his provisional pension in accordance with the relevant provisions of CCS (Pension) Rules, 1972, The officers shall be given only provisional pension and the DCRG and CVP in respect of these officers shall be withheld till the conclusion of the vigilance/disciplinary case as per CCS (Pension) Rules, 1972.

3. If the name of any other STS Officer, who is due for retirement on superannuation on 31-03-2010 A/N but is not included in the above list, may also be retired on superannuation on provisional basis. The names of such DEs may be intimated to this office.

4. It may be ensured that no disciplinary / vigilance case is pending or contemplated against any of the officer mentioned above. If any such case comes to notice, only provisional pension shall be granted to the officer [s] and his DCRG and CVP shall be withheld till the vigilance clearance is accorded.
