In case any disciplinary/vigilance case of type referred to in DOP&T OM No. 22011/4/91-ESTT(A) dated 14.09.1992 is pending against the officer or some punishment like stoppage of increment is current, he/she should not be promoted and matter should be reported to this office immediately.

3. The officers now promoted, in case officiating on local arrangement basis in the grade of Accounts Officer by an order of the Circle, should be reverted to their substantive grade and be promoted afresh in compliance with this order, after giving a break for one day.

4. The seniority of the officers will be communicated separately.

5. 
