2. The officers should not be relieved unless he/she has served minimum of 2 years in the Circle. Further the stay of the officer at his/her last station of posting should be more than 2 years else the transfer shall be treated on own cost.

3. It should be ensured by the Circle to which the officers are transferred that the station of posting on transfer is not the same as in the last Circle. Posting of officer to the sensitive/non-sensitive posts may be decided by the concerned Circles as per prescribed norms circulated by the DoT and O&M Branch of B.S.N.L. Corporate Office from time to time.

4. The date on which the above orders are given effect to may be intimated and necessary charge report submitted to all concerned.
