We would like to draw your kind attention in the above reference wherein DGM (SR) BSNL Corporate Office, New Delhi has issued direction to all CGMs of BSNL, GMs (Pers/Admin.) for taking suitable actions / steps on the proposed agitation programmes of United Forum of BSNL Executive Associations' comprising AIBSNLEA. AIGETOA and AITEEA. Going by the verbatim used in the letter, the difference in letter issued earlier and the letter under reference is remarkably visible. The threats issued in the letter issued by SR Cell of BSNL Corporate Office, New Delhi shows the indifferent, callous and intimidating attitude of the SR Cell towards these associations. United Forum has given the agitation call under compulsion as none of the important HR issues are being settled for the last two years despite the repeated requests made by these Associations in the formal/Informal meetings. Thereafter the membership verification, SR Cell is completely acting as dictator and has killed the democracy by not giving recognition to AIBSNLEA in 17 Circles where AIBSNLEA has won the election in the membership verification and instead has given recognition to SNEA (I) who got defeated in these circles.

United Forum of AIBSNLEA. AIGETOA and AITEEA has served the agitation notice against nonsettlement of the legitimate pending HR issues and the killing of democracy.

We would, therefore, request you to kindly intervene in the matter and instruct the SR Cell BSNL Corporate Office. New Delhi to be fair and impartial in their approach and settle the long pending HR issues at the earliest to avoid agitation. Also, request to allow democracy to prevail by honouring the mandate of executives given during MV to AIBSNLEA.
