**ORDER**



Before implementation of these order(s), the Circle(s) must ensure that Presidential orders for absorption of these executives in BSNL have been issued and executives to be promoted are working in the grade of STS (CAO/AGM) on regular basis in the circle. If the executives are not working in the circle shown against col 'Present Circle', the earlier orders of transfer should be implemented first, with direction to report to the concerned circle of posting shown against him and the matter should be reported to CO BSNL HQ.

4. On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009 and further modifications on the subject issued from time to time.

5. This promotion order is issued in compliance with the directions/orders of Hon'ble Courts in the cases, filed by some of the above mentioned executives.

6. The Executives would not have any claim for their seniority/regular service in DGMs grade of Telecom Finance based on this ad-hoc promotion. Their seniority will continue to be determined with reference to their basic seniority in the substantive grade of CAOs/AGMs of Telecom Finance Service (STS level).
