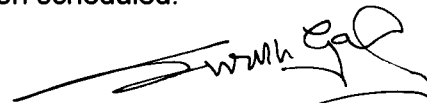

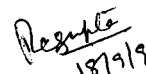
The induction level training of the above mentioned JTO(Civil) shall be conducted simultaneously along with the direct recruited JTO(C)s as and when scheduled.
