




Respected Sir,

We are constrained to bring the following facts and circumstances to your kind notice for taking immediate corrective action from your end please.

1. That Sir, we have come to know from news paper reports that the vigilance section of your good office has initiated an inquiry into the alleged financial irregularities in terms of several crores of rupees committed by Shri Hari Singh Pawar, the then GMTD/ Jorhat.
2. That Sir, as you are aware, Shri Pawar has already retired from service on superannuation on 31st March, 2020. But we have learnt from reliable sources that the officer has been visiting the office of GMTD/Jorhat almost regularly even after retirement and handling the files and documents in connivance with the present GMTD Shri. **Ranjit Kumar Basumatary**, who was holding the post of DGM (Planning) during occurrence of the alleged financial irregularities.
3. That Sir, we are surprised to learn that the retired officer Shri. Pawar has even taken with him about ten number of office files to his residence on 2nd May, 2020 ! One can easily understand that the officer might be doing these unauthorized and illegal activities to temper with the records and destroy evidences available against him with regards to the alleged financial irregularities.

In view of the above, you are requested to take immediate corrective actions in this regard please.
