
Sub: Provisional Seniority List in various grades of Electrical Wing for absorbed Executives in BSNL-inviting objection/ discrepancies regarding

The provisional seniority list in the grades of PCE (E)/CE (E)/SE (E)/EE (E) in respect of absorbed regular executives of BSNL is appended for circulation/information to all concerned (Annexure-A/B/C &D).

2.0 Provisional Seniority Lists in various grades has been prepared based on the following:

- (a). The names of officers working in BSNL on deemed deputation and repatriated to DOT are not reflected in the lists.
- (b). Names of the officers of various grades who have been retired as on dated 01.01.2012 are not reflected in the grade seniority list.
- (c). The inter-se-seniority in EE (E) grade is determined with reference to the rotation of vacancies following the principle of Quota-Rota. In order to arrive at inter-se-seniority between Group "A" & Group "B" officers, they are rotated as per the BSNL MS RRs.
- (d). The names of the officers who have already been promoted to next higher grade on regular basis are also removed and positioned in the seniority list of next higher grade as per BSNL MS RRs.
- (e). The seniority lists prepared are provisional subject to outcomes of various court cases in respect of seniority and subject to the discrepancies noticed in respect of Name, Date of Birth, HRMS No., date of Promotion etc.

3.0 Representations regarding errors/ omissions, if any, from the concerned Executives may be sent to this office after verification of facts like Name / Date of Birth / Category / Date of entry in the Deptt./ Date of regular appointment in the grade etc., latest by 08.02.2012 for releasing final seniority list of absorbed regular Executives of BSNL.


