The brief of the case is that after issue of C.O. letter under reference 1 & 2 the CGM, WB Circle, Kolkata vide his order under reference-3 has cancelled the looking after arrangement made locally by the CE( C) without approval by the CGMT, WB Circle. It is worthy to note that these executives were not the senior-most in the circle.
