**Subject: Request for Transfer in the grade of SDE (E) on own cost. Case of Sri S.K. Mohanty, SDE(E), Gwalior, M.P. – Reminder regarding-
Reference: AIBSNLEA letter of even no. dated 25/02/2014.**

Respected Sir,

Kindly refer the letter under reference wherein AIBSNLEA has requested your good office to consider the request transfer of **Sri S.K. Mohanty, SDE(E), Gwalior on own cost** due to his compelling family problems. The brief fact of the matter is that the officer has lost his parents and his wife suffering from anemia, thyroid problem & low B.P, is residing in the home town of Bhubaneswar along with her two school going children. This is clear from his two representations latest being dated 10/02/2014. His first application dated 05/03/2013 has been forwarded to your office with due recommendation by the CE(E), MP Circle on dtd 09/05/2013. He has now completed two years & seven months at Gwalior with many hardships. Further stay at Gwalior will be miserable for him.

In Odisha Circle, out of 15 sanctioned/working strength of SDE(E), 4 SDE(E) are looking after in the grade of EE(E), thereby creating 4 Nos. temporary vacancies in the grade of SDE(E). These four posts can be safely filled up by the administration considering the fact that one SDE (Sri M.K.Haldar) is in the zone of consideration for promotion to the grade of EE and another SDE (Sri S.C.Pradhan) is in the verge of retirement next year. It is also a fact that many out state SDE(E)s are posted in Odisha since 1999 & 2003. As a result the SDE(E)s of Odisha Circle are being posted in other Circles. The present posting order no. 2-66/2013-Electrical dated 08/05/2014 vide which three executives of Odisha have been posted in HP/Bihar is a clear example in this regard. This has created resentment among the cadres. Odisha being a profit making Circle and Odisha electrical wing being responsible for maintaining electromechanical services of all BTSs, sufficient manpower shall be posted in Odisha Circle.

We would also like to state that one SDE(E) Sri M.K.Haldar, after completing three years at Bhubaneswar has requested for own cost transfer to Kolkata and the case is pending in your office. In view of the above, we feel vacancy is not a constraint for posting of Sri S.K. Mohanty in Odisha Circle. It is therefore requested to consider the transfer cases sympathetically so that the motivation of the officers will be intact.
