Request for promotion to the post of DE/AGM (ad hoc) based on the DPC

held for 1860 posts - reg.

Sir.

It is in continuation to our letter dated 04-09-2013, While conveying our heartful thanks for carrying out one of the massive DPCs in BSNL after successful contest of numerous litigations, we would like to submit the following few lines for your kind and immediate intervention:

- 1. The DPC was convened for promotion from SDE (T) to DE/AGM (ad hoc) for 1860 posts during June/July, 2013. In the said DPC the names of 1445-OC, 293-SC and 122-ST were considered for promotion. However, the promotion orders were issued to 1693 officers on a time bound manner to avoid probable stay orders/litigations from various Courts. Further, it is learnt that the names of 167 candidates have been ignored due to intervention of CLO, SCT-Cell without any justified reason.
- A look (table below) at the names considered by DPC for promotion and the promoted officers can reveal that major number of OC candidates were ignored by the competent authority while issuing promotion orders:

- 3. It may be stated that OC candidates from 1982-Batch JTOs (DR)/1998-Batch SDEs (T) are still awaiting for their turn of promotion. It is very heartening that even after a long wait i.e. 15 years in the grade of SDE (T) and found suitable by the DPC, the said 134 OC candidates could not got their legitimate promotion due to some administrative glitches.
- 4. In view of the above, it is therefore requested you to kindly intervene in the matter and issue necessary instructions to concerned authorities for issuing necessary promotion orders to the remaining 167 candidates who are waiting for the last 15 years for promotion.
