Subject: Request for cancellation / modification of Posting orders on Promotion of DEs -

reg.

Reference: No.4l2 16/2014-Pers.I Dated August 20, 20l4

Respected Sir,

On the above cited reference and subject matter, we would like to draw your kind attention to the Promotion Orders of 2303 DEs on Regular basis wherein about 1700 DEs working on Adhoc basis have been regularized and about 600 SDEs have been promoted to DE Posts. Out of the 600 DEs, about 300 DEs including the lady executives on promotion have been transferred to distant circles on the pretext of non-availability of DE vacancies. Also the SDEs who have completed 57 ½ years age have been transferred.

The fact remains that in the most affected circles i.e. Karnataka, Chennai TD, Tamilnadu, Maharashtra, STR and UP (East), at present the DEs vacancies are more than 30% and shortly promotions of 480 DEs to DGM are also going to take place which will further create some more vacancies of DEs in these circles. The shortage in other circles is continuing for the last many years but this cannot be filled up in one DE promotion order on pro-rata basis which will adversely affect the revenue earning circles and creating lot of difficulties to majority of DEs on promotion due to distant circle postings. Hence, it is not in the interest of BSNL as well as in the interest of individual DEs.

Moreover, the DEs allotted to NTR & ETR circles have been further posted to the remotest areas and stations just to harass and frustrate them.

In view of the above, it is requested to kindly intervene in the matter so that all the vacancies of Karnataka, Tamilnadu, Chennai TD, STR, Maharashtra and UP (East) Circles are filled up first and thereafter the excess DEs may be posted to the nearby deficit circles in the interest of BSNL and individuals. Also the genuine medical ground and immunity cases are considered favorably.
