**Sub: Regarding reimbursement of Pay and Allowance of BSNL employees working on deputation in various wings of the DoT.**

**Respected Sir,**

On the subject cited above, it is submitted that a large number of BSNL employees are working on deputation in various wings of DoT viz. TERM Cell, CCA etc.

The Salary, EPF and Pension Contribution for these employees are being paid by BSNL. The EPF is also drawn and paid to EPF Office by BSNL on monthly basis.

As per agreement with BSNL & DOT, the salary and other expenditure is to be reimbursed by DoT. The claim is to be settled on monthly basis.

**It is regretted to inform that a huge amount of reimbursement is now pending with DoT. Out of which, Rs. 2,40,69,566/- are pending from DoT Cell, Ahmedabad only. A copy of the communication made with CCA, Ahmedabad by Gujarat Telecom Circle vide letter number TAC/21/Settl/Misc-Corr/12-13/76 dated 02.08.2013 is enclosed herewith for ready reference please. This amount is a matter of audit objection by P&T audit, internal audit and statutory audit.**

It is, therefore, requested to kindly look into the matter and arrange to issue necessary directions to the concerned officers to reimburse the pending claims including above in respect of pay and allowances of BSNL employees who worked on deputation basis in the various wings of DoT.
