R/Sir,

Please refer to our letter mentioned above vide which we have requested for modification of BSNL MSRR 2009, but no action has been taken till date.

In this regard it is stated that in the year 2001 and 2002 the restructuring of JE (C/E) and AE (C/E) have been approved by BSNL Board and the designation has been changed as JTO (C/E) and SDE(C/E) as well as pay scale has also been changed at par with JTO/SDE (Telecom).

As per Government of India, Ministry of Education and Social Welfare (Dept. Of Education Technical) vide letter no. F16-19/75/T-2 dated 26 May 1977,(copy enclosed) has clearly categorised that the Government of India has decided to recognise a Diploma in Engineering in appropriate discipline plus total 10 years of technical experience in the appropriate fields is recognised as equivalent to the degree in engineering. It is considered valid for the purpose of selection to gazetted posts and services under the Central Government or state Government.

Secondly Principal CAT New Delhi has issued judgement vide OA-2651/2012 dated 26/4/2013, copy enclosed which is self explanatory.

Keeping in view the above facts you are requested to kindly intervene in the matter and issue necessary instructions to the concerned officers to give the parity at par with JTO / SDE (Telecom).
