Sub: Request to immediately address the serious and unwarranted diversion of posts from two circles in the cadre of SDE (E)–Reg.

Ref.: BSNL CO letter number 6-5/2007-Elect dated 22.10.2013

Respected Sir,

As you know SDE (E) & JTO (E) working in the Electrical Wing are looking after the maintenance of the electromechanical assets in Telephone Exchanges, viz AC Plant, DG Sets, Substation etc. in addition to the project works. Further to this the maintenance of electromechanical assets in BTS sites/USOF has also taken over by Electrical Wing.

In view of the above, we would like to present a few facts as follows:

1. Electrical Wing is also involved in saving on account of energy conservation, downsizing of services, saving measures, etc. BSNL Maharashtra Circle has recently received an award from MEDA on this account.
2. Already, there is a shortage of EE (E)-06 Nos., SDE (E)-04 Nos. and JTO (E)-74 Nos.
3. In view of this and the increased work load, requirement of additional manpower has been sent to the Corporate Office from time to time.
4. However, the recent order is in contrast to the above mentioned facts, as instead of providing additional manpower SDE (E) posts-08 Nos. (Maharashtra-04 Nos. and Gujarat-04 Nos.) have been diverted to other states.
5. The saving achieved particularly by Maharashtra Circle would not be sustainable due to diversions of these posts; moreover, it is likely that the services may also be affected.

Considering the above facts, it is requested to kindly arrange to cancel the diversion of these SDE (E) posts from Maharashtra and Gujarat Circles respectively.
