Sub: LICE for promotion of Stenos to the grade of PA in field Units.

Sir,

I am directed to say that it has been decided to hold the Limited Internal Competitive Examination for Stenos (field units) under 50% quota as per the Personal Assistant (circle cadre), Recruitment Rules, 2004 circulated vide BSNL letter No. 22-8/2002 Pers-II dated 20th February, 2004 and the syllabus/Examination scheme circulated vide letter No. 25-16/2005-Pers-II dated 21.2.2007. Circle should ensure that the vacancies under 50% quotas for LICE in the Circle are notified keeping in view the vacancies and the rosters of the concerned Circle.

2. The Limited Internal Competitive Examination for Stenos (field units) may be held in the month of August 2007 after observing the usual formalities of giving 3 months' advance notice as per rules. The CGMs may fix the exact date for holding the examination as per their local convenience and constraints. The eligibility of the candidates to appear in the Limited Internal Competitive Examination shall strictly be according to provisions laid in the Recruitment Rules of PA (field units) circulated vide letter No. 22-8/2002 Pers-II dated 20th February, 2004.

3. Examination may be conducted centrally by the concerned Circle in accordance with the rules laid down in Appendix no. 37 of P&T Manual Vol IV and instructions issued in this regard from time to time.

4. All post examination work such as nomination of examiners, evaluation of answers books by such examiners, preparation and declaration of result, etc. will

be undertaken by the respective Circles, as being done in other decentralized examinations. **The entire process of holding the examination may please be completed within six months of the date of issue of this letter.**

5. **In the event of any query relating to eligibility conditions, Circles should refer the same to ADG (Pers.-II), BSNL Corporate Office for clarification.**
