Subject:- Method of pay fixation in IDA pay scale in respect of absorbed officials of BSNL who were promoted after 1.10.2000 and opted IDA pay scales from the date of their promotion/retirement-reg.

Sir.

I am directed to refer to this office order No.1-5/2004-PAT (BSNL) dated 30.6.2004 and to say that the issue of mechanism of fixation of pay in respect of absorbed employee of BSNL who have opted IDA pay scales w.e.f. the date of their promotion/retirement (whichever is earlier) which falls after 1.10.2000 as per Para 5 of the Presidential Orders issued for their absorption in BSNL is under consideration in DOT.

- It is understood that some circles have fixed the pay of the absorbed officers, who opted for fixation of their pay in IDA from the date of promotion after 1.10.2000, in CDA pay scale on date of promotion after 1.10.2000 under normal FR and thereafter the enhanced pay of CDA was converted into IDA pay on point to point basis.
- Now DOT has requested to intimate the financial implication of adoption of methodology mentioned at Para 2 above vis a vis the situation had they not exercised such option to continue in CDA pay scale till the date of promotion/retirement after 1.10.2000.
- In view of above, you are requested to send detailed information with financial implication as per enclosed proforma to this office immediately for onward transmission to DOT.
