This Association has been requesting for granting of meeting at the level of CMD BSNL to discuss some pressing issues of Executives in BSNL. But we regret to mention that till date no formal meeting has been granted to this Association hence, most of the important issues of BSNL Executives remains unsettled. This is causing serious discontent in our members. The following pending issues are agitating the minds of our members which needs to be addressed urgently.

- 1. Finalisation of Group 'A' RRs and immediate regularisation of Adhoc Group'A' level Executives.
- 2. Change of designation on time bound promotion to BSNL Executives.
- 3. One time placement of SDE to Sr. SDE Grade on 01-10-2000
- 4. Implementation of the upgraded Pay scales w.e.f. 01-10-2000 for various cadres on notional basis.
- 5. Revision of Pay Scale of AD (OL) as per the recommendation of 6<sup>th</sup> CPC.
- 6. Creation of PPS posts in field units and BSNL Corporate Office.
- 7. Holding of DPCs to fill up all vacant STS / JAG / SAG / HAG level posts by BSNL Executives.
- 8. Absorption of ITS Officers in BSNL.
- 9. IDA Pension revision of BSNL pensioners.
- 10. Review of ACP withdrawal order of JTO/SDE (Civil).
- 11. Implementation of DPE OM dated 2<sup>nd</sup> April-2009 regarding increase in revised basic IDA Pay i.e. 68.8% to 78.2%.
- 12. Grant Perks & Allowances to BSNL Executives in the revised IDA Pay scales.
- 13. Settlement of E-1A, E-2A & E-9A Scales in revised scales in BSNL.

We shall, therefore, request you to kindly grant us a meeting to discuss all above mentioned pending Items at the earliest.
