Subject: - Submission of Suggestions in connection with conducting Limited Departmental Competitive Examination in Civil/Electrical wing of BSNL - regarding.

Sir,

It is in connection with the notifications notified by the BSNL on the subject matter, we would like to submit our suggestions as mentioned below:-


1. The ACR must be criteria for consideration as eligibility condition to appear in the LDCE, otherwise no JTO (E/C) will care for SDE (E/C) / EE (E/C) and other senior officers in Electrical/Civil wing of BSNL.
2. The Officer who has completed his / her probation period should only be made as eligible candidate. This is to be noted that passing in the simple Accounts Paper is also a criteria, failing which probation period is extended as mentioned in the appointment letter of J.T.O (E/C).
3. The Year-wise vacancies should be mentioned before conducting LDCE.
4. The candidate should be made eligible with respect to the year of vacancy falling therein. Means, one who joined department in year 1999 should be made eligible only for the year of vacancy of year 2003, 2004 or so on i.e. 4 years condition must be satisfied as one of the eligibility condition.
5. The Vigilance clearance must be made an eligibility condition, otherwise nobody will fear for audit Para & to carry out work -as per the specifications, fully satisfaction to Engineer-incharge.

6. The LDC Examination should be conducted on the basis as field oriented, so that field experience could be utilized in the development of BSNL.
7. If any criteria is not made, a good number of JTO (E!C) will submit there application from transfer from Field unit to planning unit having a pressure from ministry, resulting BSNL USO project work will suffer.
8. There are so many other reasons, which should be counted as criteria making an eligibility condition for appearing in the LDCE.
In view of the above points, it is therefore, requested to include above suggestions! points on the subject matter.
