Sub. : - Regarding Convening AIC of TESA.

Comrade,

This is with reference to your e-mail on the above mentioned subject received on 11th July'2008, wherein you have mentioned that the reply of my letter is in the same line as that of the reply send by you to Com. Amit Gupta, don't satisfy my letter offering to hold All India Conference of TESA (I) in Rajasthan at any suitable venue. It seems that you are determined to hold the AIC at Chennai without getting the approval of All India Central Executive Committee Meeting, which is violation of the constitution of TESA.

There are many instances where, you have violated the provisions of the constitution of TESA i.e. not holding of the All India Conference for last five & half years since last AlC Mysore in Dec'2002 and arbitrarily writing vide letter no. TESA/CHQ/CMD/2008/01 dated 26.06.2008 to Director (HRD), BSNL regarding issuance of corrigendum of BSNL Corporate Office letter issued on 29.04.2004 for granting limited trade union facilities to AIBSNLEA by merging 10 DoT recognized associations including TESA in AIBSNLEA. It is against the decision of TESA CEC Meet held at Kolkata in March'2004; the same was communicated to the National Convention of AIBSNLEA Kolkata.

Hence, It is requested that the venue of next AIC of TESA (I) should be decided in the CEC Meeting of TESA as per the provision of the constitution of TESA. I have already offered to hold the next AIC TESA in Rajasthan at any suitable venue but if due to any reason it is not possible to decide for Rajasthan Circle, I further offer you to hold the CEC TESA at Jaipur, Rajasthan before the AIC of AIBSNLEA on 26th August'2008, which will

be convenient to so many TESA CHQ Officer Bearers / Circle Secretaries/ CWC Members in getting Special C/L and will obviate the additional financial burden of TA/DA.

Presently, I am Circle Secretary of Rajasthan Circle TESA in which ever forms TESA organization remains today. Kindly instead of reading in between the lines and concentrating on typing mistake of the letters, kindly address the main issue i.e. "why TESA AIC could not be held so far? Despite the fact that it is over lived for years together and its present GS has retired from the service so many years before particularly when TESA constitution do not approve such an incumbent to continue. Now we want TESA AIC should be held without further delay and for deciding the venue of AIC, CEC meeting of TESA should be held immediately because only CEC can decide such matter. In that process only we have offered proposal to CHQ that whether CEC can be held in Rajasthan alongwith or one day prior to ensuing AIC of AIBSNLEA at Jaipur.

The proposal is justified in the sense that this will help to work out the problems of leaves as well as the expenditure to a great extent as stated above. We hope you will consider this favorably.
