- the officer is not on deputation to TCIL or any other organization.

2. The officer is required to join his promotional assignment within a period of 40 days from the date of issue of this order. The CGM concerned may please ensure that the promotion/posting order in respect of officer is issued in time to join his promotional assignment within the prescribed time limit of 40 days from the date of issue of this order.

3. In case the officer concerned fails to join the promotional assignment within the prescribed period of 40 days, he should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Furthermore, no request for modification of promotion order shall be entertained after the expiry of 40 days period.

4. CGM concerned is further directed that the pending request of the officer for modification of the promotion/posting order cannot be taken as ground for holding of the implementation of the promotion order in respect of the officer.

5. Seniority of the officer shall be determined in accordance with the rules in force.

6. The aforesaid promotion order is subject to the outcome of final decision in any lawsuit(s) pending before any court(s) regarding regulation of seniority/promotion in SDE (TF) grade.

7. The date on which the above orders are given effect to may be intimated and necessary charge report may be submitted to all concerned.


