In case, station of posting is not received, then Executive (s) may be relieved with the directions to report to concerned Circle office. Further, the circles are advised to relieve the Executive/s posted in <a href="https://executive.net/">hard/</a> soft tenure stations only on completion of his/her prescribed Hard/ soft tenure stay period including excess leave period, as per rules/instructions.
- 5. The Circle IFA(s) are requested to relieve the Executive(s) under transfer without waiting for joining of substitutes in their places.
- 6. TA/TP MAY BE REGULATED AS PER THE GUIDELINES ISSUED BY BSNL VIDE LETTER NO: 19-27/2002-L&A (PART) DATED 15.04.2004, OM NO.412-10/2009 PERS I DATED 09.05.2012 AND OTHER PREVAILING GUIDELINES ON THE SUBJECT.
