The VC has been with held in respect of **Shri Langade Subhash Damodar** (S.No.31) (HR No.196901131), Maharashtra Telecom Circle Maharashtra Circle is requested to regulate his provisional pension in accordance with the relevant provisions of CCS (Pension) Rules 1972. The DCRG and commuted value of pension (CVP) in respect of the above mentioned officer should be withheld till the conclusion of the vigilance/disciplinary case as per CCS (Pension)Rules, 1972.

If the names of any other SDEs (Telecom)/PS retiring on superannuation on 30.09.2009 A/N and not included in the above list, provisional superannuation order may be issued by the circle concerned incorporating para 2 above, subject to confirmation by this office. Names of such SDEs(Telecom)/PS may be intimated to this office immediately. It may be ensured that the aforesaid officials have been absorbed in BSNL.
