
2. The concerned zonal PCE(C)/CE(C) will further issue specific posting orders. While deciding the postings the concerned units will ensure field/planning rotation on the basis of having completed four/two years tenure in field/planning by the above Executives.

3. The Executives shall be relieved within a week's period from the date of the transfer order, by making local arrangement.

4. The Executives shall not be granted leave unless they join their new place of posting.

5. The Executives who have not completed two years on their present station of posting shall not be entitled for TA/DA/JT.

6. In the above transfers, the posting mentioned in their remarks column may be treated as posting on transfer in place of the same in Column 6.
